AGREEMENT

This Agreement is made by and between DSCC and Bureau of Services for the Visually Impaired (BSVI) on the date set forth by the signature below.

Whereas the Defense Supply Center Columbus (DSCC) agrees:

- 1. That BSVI will provide all coin operated vending in Buildings 20 and 21.
- 2. That BSVI will operate a sundry store in Building 20.
- 3. That BSVI will operate a sundry store in Building 21.
- 4. To provide four 200 sq. ft. storage areas, two in Building 20 and two in Building 21.
- 5. To continue to provide the existing amount of off-site storage.

The Bureau of Services for the Visually Impaired (BSVI) hereby agrees to:

- 1. To pay to the DSCC non-appropriated fund activity a commission of 4.8% of gross revenue after taxes from all present and future BSVI operations in the DSCC buildings presently designated as Buildings 20 and 21.
- 2. Provide all coin operated vending in Buildings 20 and 21.
- 3. Operate a sundry store in Building 20.
- 4. Operate a sundry store in Building 21.
- 5. Construct an enclosure for the storage areas in Building 21 to suit their needs contingent on approval of the plans by the installation. (The areas in Building 20 will be separate rooms.)
- 6. Decline all manual food service operations including all cafeterias, quick pick, Officers' Club, food court, catering, and all installation vending outside of Buildings 20 and 21 including those currently operated by a BSVI vendor.

DSCC AND BSVI FURTHER AGREE:

- 1. To work together to try to locate a closet-sized area near the Building 21 sundry store as possible in the building usage plan.
- 2. To work together to have some cabinet-sized storage within the break rooms as possible in the building usage plan.
- 3. That this agreement will take effect on July 1, 1999 and remain in effect for the life of Buildings 20 and 21 as Department of Defense operated buildings or until DSCC and BSVI agree to renegotiate this permit.
- 4. This constitutes the complete agreement between the parties and any representations made verbally or in writing prior to the effective date of the agreement have no force or effect. Any changes, modifications or amendments shall be made and agreed to in writing, upon the mutual agreement of the parties.
